


1. THE CONGRESS PROGRAMME

- •It was organized the best way it can. The FIN guys and Alex did a great job.




2. THE CONTENT OF THE PROGRAMME

3. ENOUGH TIME FOR DISCUSSION



4. PARTICIPATION IN DISCUSSION




REMARKS:

•Not in all discussions, but the discussion about the regulations (or the non-regulations) for training in the woods in the Scandinavian countries was very interesting to me.




5. DIFFICULT DISCUSSION

- •Yes, because od my low English level.




6. DELEGATES PRESENTING NATIONAL ACTIVITIES

- It is better that all countries have their national presentations.




7. GUESTSPEAKERS ON RELEVANT TOPICS

- It is good that there were no need for interpreters.




8. BALANCE BETWEEN FORMAL MEETINGS AND SOCIAL ACTIVITY

- A lot of discussions is continued during social activity.




9. THE FORMAT OF THE CONGRESS

- I hope there will be next Congress.




